





- 1. **Meeting Purpose:** The meeting aims to discuss and potentially approve a special resolution ("Easement Resolution") allowing the Club to establish a "Conservation Agreement" with The Georgian Bay Trust Foundation ("GBLT") to register a conservation and access easement on a part of the Club's property called Open Lands.
- 2. **Conservation Agreement:** A nearly finalized version of the Conservation Agreement (Schedule B in the Notice of Meeting) has been reached after negotiations between the Club and GBLT, involving input from independent legal and tax advisors.
- 3. **Consistency with Prior Version:** The current version of the Conservation Agreement does not substantially differ from the version presented at the 2022 AGM, where members supported finalizing the agreement terms. Notable changes have occurred externally, including an independent appraisal of Open Lands and GBLT securing a Federal grant to compensate the Club for the easement.



- 4. **Expected Compensation:** Approval of the Easement Resolution (66 2/3% majority) would result in around C\$420,000 compensation and a Charitable Tax Receipt of approximately C\$2,933,900. The Club plans to apply for tax benefits under the Canada Ecological Gifts Program, potentially increasing tax offsets and carry-forward period.
- 5. **Legal and Tax Considerations:** Independent tax advisors have assessed the proposed transactions, indicating potential tax offsets. Legal review confirmed the agreement's design to protect Open Lands while allowing Club members to continue using them.

Board Support and Consideration: The Board, excluding one member abstaining solely due to the term length, supports voting "Yes" for the Conservation Agreement and Easement registration. The Board, and Land Stewardship Committee weighed various factors and concluded that the benefits of the Easement surpass associated risks. Members should carefully evaluate these factors, outlined in the Notice of Meeting before voting.

Process: The recommendation follows a robust process that considered all alternatives, and aligns with an extensive 7-year community consultation process - reflecting strong support throughout.

Timing: The grant awarded to the GBLT to compensate the Club for the Easement expires this fall and there is no guarantee that future grants will be available. The Club puts itself at risk of not receiving any financial benefit (or a significantly reduced benefit) for the Easement should we delay a decision further.





EASEMENT RESOLUTION

- The Club is authorized to execute, deliver and perform its obligations under that certain Conservation Agreement (the "Agreement"), substantially in the form presented to the Club's members on August 10, 2023, with such housekeeping amendments as any director or officer of the Club may approve.
- 2. Any director or officer of the Corporation is authorized to: (a) execute and deliver the Agreement; and (b) execute and deliver all other documents, agreements and instruments (collectively, "Ancillary Documents"), and do all acts or things as may be necessary or desirable to give effect to these resolutions and the transactions contemplated in the Agreement.
- Execution of the Agreement and any Ancillary Documents by any officer or director of the Club will be conclusive evidence of his or her approval of the Agreement or Ancillary Document, as applicable, and that such Agreement or Ancillary Document, as applicable, is the version approved by this resolution.
- 4. Any and all actions heretofore taken and documentation heretofore delivered by any officer or director of the Club in respect of the Agreement or any documentation related thereto or otherwise in furtherance of the foregoing resolutions, is hereby ratified, adopted, approved."




Voting Results
